Purpose of processing

Your data is collected, processed and may be used for the following purposes:

- Use of our website offering
- Making contact and communication
- Use of cookies to ensure the functionality of the website
- Marketing purposes
- Compliance with legal and regulatory requirements or obligations, insofar as we are obliged to do so.
- Integration of offers from third-party providers for a better user experience
- Administrative work, documentation of club life, club activities, advertising

Processed personal data

TMM may collect, process or use the following data:

- Personal master data (e.g. title, surname, first name, postal address, gender, date of birth, instruments, education)
- Communication data (e.g. telephone numbers, e-mail addresses)
- IT usage data (e.g. IP address, access location and device, passwords)
- Bank data (e.g. account details, credit card numbers)
- Health and applicant data, insofar as these are provided
- Other data in connection with the association's activities (e.g. participation in events, donation contributions, meal preferences)
- Photos (e.g. portraits, group photos, event photos)

Data security and storage

Suitable technical and organizational measures are used to protect personal data from loss and unauthorized access. The data is stored for as long as is necessary or required by law.

Data transfer

The stored personal data is neither sold nor passed on to third parties without consent. This does not include the transfer of data to the following third parties:

- Companies commissioned to organize the events (e.g. hotels, BnB, Catering)
- Contract data processors

Rights of data subjects

The rights to information and rectification are based on the statutory provisions of the DPA. This includes the following points, among others:

- Right of access to the stored personal data at any time
- Restriction of processing and transfer of stored personal data
- Right of revocation at any time
- Right to lodge a complaint with a supervisory authority

Cookies

Cookies are text files used to ensure the use of the website, to improve the website or to track the use of the website. Some cookies are only stored for the duration of the visit to the website. Other cookies are stored for longer and are only deleted after a specified time, e.g. to recognize returning users, to analyse user behaviour or visit patterns or to improve website functionality for all users.

You can usually set which cookies you wish to allow in your browser settings. If all cookies are rejected, your visit to our website may be restricted or unavailable.
